MINUTES OF THE REGULAR MEETING

of the

Sanford Aviation Noise Abatement Committee *held at the* ORLANDO SANFORD INTERNATIONAL AIRPORT 1200 RED CLEVELAND BOULEVARD, LEVEL II - BOARD ROOM

Tuesday, April 12, 2016 - 9:00 a.m.

CALL TO ORDER

- The regular meeting of the Sanford Airport Authority Noise Abatement Committee was called to order at 9:00 a.m. by Vice Chairperson Krysty Carr.
- The minutes for January were approved as submitted.
- It was stated in the meeting that the terms for Krysty Carr, James Wilkes, and Andrew VanGaale are ending in September 2016. The respective boards, as spelled out in the Bylaws, for each position will need to select someone to serve in these positions for the new four year term commencing October 2016.
- Mr. Speake presented the noise complaint data for the months of January, February and March.
- Mr. Speake stated that there have been several complaints in the City of Casselberry in the past few months in the same area neighborhood, due to the Sheriff's helicopter. He stated that he spoke to the persons complaining in this area and explained the situation, which has satisfied them.
- Mr. Speake stated that he and Chairman VanGaale visited Ms. Marsden's property in the month of February and spoke with her and two of her neighbors regarding their concerns about aircraft noise. They were able to see firsthand the level of activity occurring in the area. Following the visit, Ms. Marsden contacted some of the County Commissioners regarding her concerns. Mr. Speake stated that the airport followed up with the Commissioners and advised them that there is not much that could be done to ease what is happening where she lives. It was stated in the meeting that the noise in this area is high as the many of the aircraft departing the airport turn to the north over her property while they are climbing to a higher altitude. Both actions require the aircraft to be at a higher power than straight and level flight. Committee Member Rocky Harrelson asked why the aircraft couldn't climb higher, sooner than over Ms. Marsden's house. ATC responded that it was due to the fact that traffic coming out of Orlando International is already at the higher altitudes at this point and there is not enough airspace to accommodate all aircraft at the higher altitudes at the point they are at over her neighborhood. Mr. Harrelson asked if it would be possible to have departing aircraft fly straight out another two to three miles to the landfill and then make the turn to the north. Mr. Privette stated that it would be difficult to do because it would interfere with Daytona's airspace and would also interfere

with flight training areas. Mr. Speake clarified that Ms. Marsden's property is outside of the 65 dnL range.

- Mr. Speake asked Mr. Schlegel to reach out to Orlando Approach to see if they can designate someone to attend the SANAC meetings in place of Mr. Kelly Ellison who has retired.
- Mr. Speake stated that he believes the online noise complaint form needs to be modified so that those who are complaining cannot leave certain data fields incomplete. He would like to modify the online complaint form so that it is mandatory to fill out the name, address, city, zip, and whether they are a first time complainer. If these fields are not filled out, the person will not be able to finish filing the complaint.
- Mr. Speake stated that traffic for the Orlando Sanford International Airport increased 30-40% from 2014 to 2015. He stated that he does not anticipate GA operations to increase in the next year, but Air Carrier operations are expected to increase slightly due to new international and domestic flights being added.
