CALL TO ORDER

- The regular meeting of the Sanford Airport Authority Noise Abatement Committee was called to order at 9:00 a.m. by Vice Chairman Andrew VanGaale.
- The minutes for January were approved as submitted.
- A discussion regarding a noise complaint from Mount Dora. It was stated that there is a possibility of an Aircraft arriving/departing this Airport operating over Mount Dora when deviating from the standard flight pattern due to weather.
- Mr. Speake stated that there have been numerous complaints from Winter Springs/Oviedo of a rumbling noise accompanied by shaking. He has called all of these people back and informed that them that it is highly unlikely that this is being caused by aircraft from the airport as all of the complaints are 5 to 11 miles away. He stated he spoke to several residents regarding the noise and believes it's due to an Earth phenomenon and/or other types of noise in the area.
- Mr. Speake stated that the month of March was the fourth busiest month the Airport has had in four years for total operations.
