- The regular meeting of the Sanford Airport Authority Noise Abatement Committee was called to order at 9:00 a.m. by Vice Chairman Andrew VanGaale.
- The minutes for April were approved as submitted.
- The SANAC Committee has nominated Randell Baeza to be the new General Aviation representative.
- Mr. Speake stated that the Airport is on track to have 300,000 operations by years end and that the last three months have been the busiest months with the increase starting in April.
- Mr. Speake stated that there have been quite a few late arrivals and departures lately due to various irregular operations which have generated late noise complaints.
- It was stated in the meeting that the DNL range is currently being studied by the FAA and being researched to determine whether to keep it as is or revise it.
