#### **CALL TO ORDER**

- The regular meeting of the Sanford Airport Authority Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Andrew Van Gaale.

#### **Air Carrier**

- It was stated that Allegiant Air is entering one of the busiest seasons they have ever had this year.

#### **General Aviation**

#### **FAA**

- It was stated that new Metroplex initiatives will begin in November.
- Mr. Ellison stated that the Signatory Lake Jessup and Lake Monroe arrivals will be published soon. He stated that the VFR charts will be coming out in January or February. It was stated that these changes will not affect noise any more than what already is taking place, as the arrivals will still be used by the same aircraft.
- It was stated that opposite direction operations are no longer allowed by the FAA. The new guidelines from the FAA do not provide an exemption to this rule to prevent noise concerns.
