MINUTES OF THE REGULAR MEETING

Sanford Aviation Noise Abatement Committee held at the ORLANDO SANFORD AIRPORT 1200 RED CLEVELAND BOULEVARD, LEVEL II - BOARD ROOM

Tuesday, January 15, 2013 - 9:00 a.m.

I. CALL TO ORDER

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Andrew Van Gaale after which the mission statement was read. The minutes for October were approved as submitted.

II. NOISE REPORT

+Presentation and comments from Committee / Public

Mr. Speake stated that for the month of October there were 25 noise complaints, the month of November 63 complaints, and for the month of December there were 14 complaints noise complaints.

Mr. Patrick Pottinger stated that he has aircraft flying over his house especially during the winter months. He stated that at times the planes go slightly east but for most of the time they go right over his home. Mr. Speake stated that the Airport could put together a track of the air traffic pattern over the course of a few months in his area for him.

Mr. Speake presented the annual data for the year. He stated that there were 510 noise complaints total last year with a total of 62 complainers.

Chairman Andrew Van Gaale has nominated Krysty Carr to continue as Vice Chair Person for SANAC. Mr. George Speake has second the nomination. The committee appointed Krysty Carr to remain as Vice Chair Person for SANAC.

+Other Liaison Reports -

Air Carrier- Ms. Brim stated that Allegiant Air would be adding new aircraft to their fleet. She stated that several airbus aircraft were purchase by Allegiant Air and that one was due to arrive for an approving run the week of February 11th. Ms Brim stated that they would be having a significant increase in operations in the month of March.

General Aviation- Mr. Mammen stated that Aerosim Academy currently has around 400 students on campus and continue to increase. He stated that that the Academy would like to start advertising in Europe to bring those students over.

FAA- Mr. Gabriele stated that the Airport has seen a significant increase in air traffic, which brought the Tower from a level 7 back up to a level 8. He stated that due to the construction going on at the Airport with the runway extension there would be an increase of operations to the south side, which may generate more noise complaints.

IV. NEW BUSINESS- Mr. Ellison stated that there is an ongoing Metroplex project, which will change operation at Orlando International Airport. He stated that this would take affect within two and half to three years.
