Mr. Ellison presented flight data over and around the area of Heathrow for Ms. McClure. He also explained the primary purpose of Air Traffic Control and why aircraft are routed over this neighborhood. It was stated that a couple of airlines currently serving the airport plan to upgrade part of their fleet with quieter and more efficient aircraft within the next several years.
