CALL TO ORDER

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Andrew Van Gaale after which the mission statement was read. The minutes for May were approved as submitted.

II. NOISE REPORT

+Presentation and comments from Committee / Public

Mr. Speake stated that for the month of March there were 100 noise complaints, 79 complaints in April and 59 complaints in May. Mr. Speake stated that the noise complaints are slightly off due to how they are submitted to the database when they are emailed. He stated that there are many residents that file repeat complaints that have repetitive language but different times on them. A discussion ensued regarding the noise complaint data base. It was suggested by the committee that a column be added to show how many households complain in each area.

A discussion ensued regarding the data results from Mr. Don Baurele's property. Mr. Speake stated that they set up noise monitoring equipment on his property from 05/10/13-05/13/13. He stated that this equipment is non-scientific and picks up all noise every 60 seconds through the time period that it is present. Mr. Speake stated that based on the data collected, Mr. Baurele is not in the 65dnl noise contour.

Air Carrier- Ms. Brim stated that Allegiant Air would be receiving a total of four Airbus A-320 aircraft by the end of the year in Sanford.
