#### I. CALL TO ORDER

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Andrew Van Gaale after which the mission statement was read. The minutes for October were approved as submitted.

#### +Presentation and comments from Committee / Public

Mr. Speake stated that for the month of October there were 6 noise complaints, 44 noise complaints in November and 41 complaints in December.

Mr. Harrelson asked if the Airport used any type of barrier when performing engine runs. Mr. Speake stated that they do not. He stated that the barriers only push the noise up and the noise would still be heard. Mr. Harrelson asked what method is used to contact the airport in order to complain about noise. Mr. Speake stated there is information available on the Airports website directing people how to file complaints. The website provides them the ability to email a complaint and provides the noise complaint hotline phone number. If they do not have Internet access they may contact the airport for the noise complaint hotline number.
