## I. CALL TO ORDER

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Andrew Van Gaale after which the mission statement was read. The minutes for January were approved as submitted.

## +Presentation and comments from Committee / Public

Mr. Speake stated that for the month of January there were 54 complaints, for February there were 65 complaints, and for the month of March there were 107 noise complaints.

Mr. Williams from the public asked about the cannons that are used to ward off wild life. He stated that he heard two booms and thought he heard them going off early Saturday morning. Mr. Dale stated that he didn't think it was the cannons because the Airport does not fire them after its dark because wild life cannot be seen. He stated that he would look into what the cause of this was.
