**I. CALL TO ORDER**

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Andrew Van Gaale after which the mission statement was read. The minutes for July were approved as submitted.

**II. NOISE REPORT**

**+Presentation and comments from Committee / Public**

Mr. Speake stated that elections for the Chairman and Vice Chairman are usually held in October. However, we are still waiting for two nominations for SANAC appointments, one from the City of Sanford and one from Seminole County, and therefore we will not be able to hold elections until the next SANAC meeting.

Mr. Speake stated that for the month July there were 22 noise complaints, 24 complaints in the month of August, and 14 complaints for the month of September. Mr. Gabriele stated that in the middle of August it was discovered that a portion of the July and August traffic was counted twice. Mr. Gabriele stated that July will end up with 3,000 more operations and that August will have 1,000 more operations than actually occurred. He stated there is no way to go back and recalculate the operations and therefore the numbers will remain as they were reported. Mr. Speake stated that in January he will report the total number of complaints for 2012.

**Air Carrier-** Ms. Brim stated that Allegiant Air has purchased new airbus aircraft. She stated that they would begin using the aircraft next year.

**General Aviation-** Mr. Mammen stated that after shutting down two of their Aerosim Flight Academies they have moved all the remaining aircraft to Sanford. He stated that they are looking into purchasing more multiengine aircraft. Mr. Mammen stated that they have increased their number of flight hours and had seen 8,000 hours for the month of September. This was a mark that had not been reached since 2006. He stated that they are estimating to have a 9, 000 hour month within the next few months.
