I. CALL TO ORDER

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Andrew Van Gaale, after which the mission statement was read. The minutes for January were approved as submitted.

II. NOISE REPORT

+Presentation and comments from Committee / Public

Mr. Andrew Van Gaale briefed the committee on the recent passing of Chairman Wes Pennington.

During the January 4, 2011 SAA Board meeting, the Board appointed Mr. Van Gaale as the new SANAC Chairman. The Board also confirmed the appointment of Mr. Michael Kern as the General Aviation Representative to SANAC.

During the SANAC meeting, motion was made by Chairman Andrew Van Gaale to approve Mr. Kern as Vice Chairman of SANAC. Vote was taken, none opposed. Motion passed.

Mr. Speake stated that as a result of Mr. Pennington's passing and a review of the Bylaws, it was discovered that a person needs to be reelected to represent Seminole County. Mr. Dale stated it should be someone who would be interested in coming to the meetings and would also be a resident of Seminole County. A discussion ensued during the meeting about the term review for each SANAC member.

Mr. Speake stated that for the month of October there were 70 complaints from 6 individuals; November there were 28 complaints from 6 different individuals; and in December there were 23 complaints from 5 different individuals. Mr. Speake stated that for the most part the number of noise complaints have remained low for the year.
