**I. CALL TO ORDER**

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Vice Chairman Mike Kern after which the mission statement was read. The minutes for January were approved as submitted.

**II. NOISE REPORT**

**+Presentation and comments from Committee / Public**

Mr. Speake stated that for the month of January there were a total of 18 complaints, 27 complaints in the month of February, and 20 complaints in the month of March. Mr. Speake stated that Mr. Robinson from Dubarry Avenue in Plymouth Florida complained that an aircraft was low and loud. Mr. Speake stated he had called him back as Mr. Robinson requested and it was determined that Mr. Robinson lives across from the Orlando Apopka Airport.

Mr. Speake stated he has begun calculating the total noise complaints for every fiscal year. He stated that the number of complaints from the previous years have shown a pattern of declining noise complaints. Mr. Speake suggested that he would like to change the format of the way the data is collected for the noise complaints, possibly by developing a new database.
