I. CALL TO ORDER

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Andrew Van Gaale after which the mission statement was read. The minutes for January were approved as submitted.

II. NOISE REPORT

+Presentation and comments from Committee / Public

Mr. Speake stated that for the month of April there were a total of 24 complaints from 14 different individuals, May had a total of 7 complaints from 6 individuals, and June had a total of 39 complaints from 17 individuals. Mr. Speake stated that the complaints regarding engine runs have increased in the last three months. Mr. Speake stated that when requested he contacts the complaint filers. When doing so, he explains to the resident that the engine runs are required by the FAA and are necessary to ensure the safety of the aircraft on future flights. Most residents are understanding of this explanation.

Mr. Speake stated that at the last SANAC meeting it was discussed that we are developing a new computer program to track noise complaints. This program will provide a database and visual output of the noise complaint locations. He stated that he should have a draft version of the program to present at the next SANAC meeting.
