**I. CALL TO ORDER**

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Andrew Van Gaale after which the mission statement was read. The minutes for July were approved as submitted.

**II. NOISE REPORT**

**+Presentation and comments from Committee / Public**

Chairman Andrew Van Gaale has nominated Krysty Carr to be the current Vice Chair Person for SANAC. Mr. George Speake has second the nomination. The committee appointed Krysty Carr as the new Vice Chair Person for SANAC.

Mr. Speake stated that for the month of July there were 9 noise complaints, the month of August there were 16 complaints and for the month of September there were 5 noise complaints.

Mr. Speake presented the new database system that will be used to input noise complaints. Mr. Speake stated that with this new system you will be able to see a map of the plotted location of each complaint and you will be able to read the comments from each person who has complained. The SANAC committee members have asked to have access to the database so that they may review before each meeting. Mr. Speake stated that by the next SANAC meeting he would be using the new database to present the noise complaints.

Chairman Van Gaale asked about the land purchases that were posted in the newspaper. Mr. Speake stated that most of the recent land purchases by the airport have been for the runway extension. Mr. Speake stated that there are about 6 properties on the west side of the airport that the Authority is working to purchase that are noise related.
