# I. CALL TO ORDER

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Wes Pennington, after which the mission statement was read. The minutes for January were approved as submitted.

## II. NOISE REPORT

## +Presentation and comments from Committee / Public

Mr. Speake stated that for the months of April, May, and June there were a total of 7 noise complaints.

Mr. Dale stated that a noise complaint was given to Mike McLean's office from Mr. Don Peters regarding engine run-ups at all hours of the night. He stated that Mr. Peters called the Airport to complain and left a message but that the airport could not track where the message was left. Mr. Dale stated that the Airport did try to contact Mr. Peters several times and left messages but the calls were not returned. Mr. Dale stated that the Airport does not have any aircraft repair companies that perform engine run-ups regularly. Mr. Dale stated that the Airlines try to perform these run-ups more often during the day than at night. These run-ups last between 10 to 35 minutes. He stated that a log is kept of what time of day run-ups are performed. Mr. Dale stated that he is going to follow up with Mr. McLeans's office in attempt to reach Mr. Peters one last time.
