I. CALL TO ORDER

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Wes Pennington, after which the mission statement was read. The minutes for January were approved as submitted.

Mr. Speake stated that for the months of July there were 17 complaints, in August there were 4 complaints and in September there were 5 complaints.

It was stated that in the coming months Mr. Jim McDonnell's noise complaints would be increasing but that his property is not in an area that is eligible for FAA Noise Funding nor is it in an area that is slated for further needs of the airport. An offer for his property was given several years ago but Mr. McDonnell refused the offer.
