# I. CALL TO ORDER

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Wes Pennington, after which the mission statement was read. The minutes for March were approved as submitted.

# II. NOISE REPORT

# +Presentation and comments from Committee / Public

George Speake presented the noise report for March. Mr. Speake stated that there were 29 complaints for the month of March. Mr. Speake stated that there were 9 complaints from David Williams and 9 complaints from Mark Kahill. There were a total of 10 different individuals that had complained for the month of March. Mr. Pennington asked if noise-monitoring equipment had been offered to be placed at his home. Mr. Speake stated that he has offered it to Mr. Williams but that he has not responded to the offer. Mr. Speake stated that Mr. Williams had stated on his complaints that he owns his own decibel meter.

**IV. NEW BUSINESS-** Mr. Speake stated that on the 11<sup>th</sup> of March at 18:03 noise monitoring equipment was left at the residence of Mr. William White. This equipment recorded 5 days worth of noise data. Mr. Speake stated that the noise equipment recorded data as low as mid 30's and as high as 80 decibels. Mr. Speake stated that most of the noise spikes occurred at night and that was with adding the 10 additional decibels for nighttime. Mr. Speake stated that the noise was still 15 decibels below the FAA requirement.
