I. CALL TO ORDER

The regular meeting of the Sanford Airport Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Wes Pennington, after which the mission statement was read. The minutes for July were approved as submitted.

II. NOISE REPORT

George Speake presented the noise report for July and August. Mr. Speake stated that in the month of July there were 46 noise complaints. Mr. Speake stated that the single largest complainer was Mr. David Williams. Mr. Speake stated that Mr. Williams property is on the approach for Runway 9L and that his property has been included as property that can be bought out of the next Noise Mitigation Grant.

Mr. Speake stated that for the month of August there were 51 noise complaints.
