CALL TO ORDER

- The regular meeting of the Sanford Airport Authority Noise Abatement Committee was called to order at 9:00 a.m. by Chairman Andrew VanGaale.
- The minutes for April were approved as submitted.
- Mr. Speake nominated Kristy Karr to be the Vice Chairperson for SANAC. The motion was second by Chairman Andrew VanGaale.
- Mr. Speake stated that there were a couple of complaints from the Sorrento area, which would primarily be the result of weather or ATC routing.
- Mr. Speake stated that the largest number of noise complaints came from Mrs. Marsden and that the Airport has offered to leave noise equipment for testing on her property but that she has declined. It was suggested that the Airport should consider putting the noise equipment in that area anyway.
- Mr. Speake stated that a total of 26 individuals have complained for the quarter.
